## APG Quarterly Going Digital in 2026 – What You Need to Know

At the 23 April 2025 quarterly meeting, APG's Board of Directors voted to transition the APG *Quarterly* (*APGQ*) journal to a fully digital format, beginning with the March 2026 issue. The preliminary results of last month's member survey indicate that the *APGQ* is one of our most valued benefits, and the Board of Directors made the decision after considering several factors.

The costs of printing and mailing the *APGQ* is one of the Association's largest budget line items. As in other areas of the economy, costs for printing and postage are rising. Over the last five years, we have seen a 30% increase in the cost of printing and postage combined, and we are anticipating a 9% increase in postage in July 2025 for magazines, as the U.S. Postal Service recently proposed. The cost savings created by this decision will allow us to reinvest the funds into other areas of APG to improve member benefits and create new services in 2026. By going completely digital and removing the limitations of specific page counts, the *APGQ* will have more flexibility for additional content.

Over the coming months, we will provide you with information on the transition process and will share tips on making the most out of your digital publication. The December 2025 issue of the *APGQ* will include much of this content. Members may have already noticed some improvements we have made to the *APGQ* web pages, including updating the searchable index, clearer organization, tables of contents, and more.

What do you need to do to prepare for the digital transition? Nothing! We will send reminders to all members and subscribers for the rest of the year to keep you up to date with the changes. If you would like to be proactive and opt out of your mailed copy now, please notify Kaye Ford at assistance@apgen.org.

Many of our library subscribers already have solutions in place for digital-only publications. We will be reaching out to these subscribers to ensure they can accommodate their users. We will be here to help support members through this transition; please stay tuned for more information.

## A Busy Month for APG's Advocacy Efforts

Rich Venezia updates on the Advocacy Committee's latest activities.

This month, the Advocacy Committee wishes to highlight the work of several organizations in the United States who are fighting hard against various reductions or elimination of agencies, as well as threatened cuts, in the hopes that our members may get involved with these various efforts.

1) The American Library Association (ALA) has started a petition to urge the House of Representatives to fund libraries after the Trump administration's elimination of the Institute of Museum and Library Services (IMLS). Many libraries provide free access to databases like Ancestry.com, and many libraries nationwide have unique local history sections or manuscripts that are crucial to genealogical research. You can read more and sign on to the petition here: https://bit.ly/3RUVpQh. (Only US residents can sign on to this petition.)



- 2) The National Humanities Alliance is working to save the National Endowment for the Humanities (NEH), which among many other things, supports access to and preservation of local archives, as well funding newspaper digitization projects. They have put together two action alerts which can be viewed here: https://bit.ly/4lNXzPb. (Again, it appears that these action alerts are mainly for US residents.)
- 3) The Director of the Syracuse University Press put together a comprehensive but concise overview of the fights to save IMLS and the NEH, both of which are battling for survival. Read more here: https://bit.ly/4jOvwNG.
- 4) The Center for Bibliographical Studies and Research (CBSR) at the University of California Riverside maintains the California Digital Newspaper Collection (CDNC). The CDNC will go offline without funding, which has been cut from the 2026 state budget. The Director of the CBSR urges California residents to write to the members of the Senate's Budget and Fiscal Review Committee's Subcommittee No. 1, and the State Assembly's Subcommittee No. 3 on Education Finance. Sample text and more information is provided on the APG Advocacy message board in the Members Area of the APG website (**Communication** > **Message Boards**).
- 5) The Council of State Archivists provides frequent posts to keep people up-to-date about various issues across the country. Follow them on Facebook (https://www.facebook.com/CouncilOfStateArchivists), Twitter/X (https://twitter.com/StateArchivists), or LinkedIn (https://bit.ly/LinkedInCSA).

If you see something, say something! The Advocacy Issues message board exists so members can alert each other about important and time-sensitive issues related to records preservation and records access advocacy.

We have one piece of good news to share out of New York State! The proposal to restrict access to vital records is completely dead in the water and will not be included in the final budget. Thanks to all who took action on this, especially the Advocacy Committee's chair, Alec Ferretti!

We continue to implore our US-based members to contact their elected officials to discuss the importance of additional funding to NARA. NARA is on life support and needs our help. Members of Congress almost never hear about the National Archives, so even a few phone calls can make a significant difference. Our elected officials only know about what's important to us if we tell them! What are the best ways to approach this work? How do we best present this information? Why is it important for families of enslavers to provide access to records from the enslavement era? What are the ethical considerations? The panelists do not claim to have all the answers to these questions, but they are initiating the conversation.

## Family History Hill Day in Washington D.C.

On 9 April 2025 members and supporters of The Records Preservation and Access Coalition (RPAC) participated in **Family History Hill Day**. The goal of the event was to encourage our federal legislative representatives in Washington, D.C. to support "robust" funding for the National Archives and Record Administration (NARA) and The National Historical Publications and Records Commission (NHPRC). We also added our voice to support the Institute of Museum and Library Services (IMLS). Loss of grants and funding from various federal organizations will have a serious impact on these organizations' ability to deliver the records and digital images that we need, and that the government needs to provide services.

APG was well-represented by Suzanne Hoffman (IL), President, and Alec Ferretti (NY), Board Member and Advocacy Committee Chair. Other participating APG members, representing a variety of organizations, included David Rencher, Jen Zinck, Adrianne McQuillan, and Susan O'Connor. Each of our participants had a meeting with their state's legislators to encourage them to sign the bipartisan House and Senate "Dear Colleague" letters urging their peers to support NARA. Meetings were held with 11 different state senators and representatives.

The meeting held with Sen. Warren's office (D-MA) was with her Special Advisor in charge of drafting the bipartisan letter. As a result of our efforts, we received a draft of this letter and had the opportunity to contribute to the content for the Senate version. We are also hoping to receive an early review of the House version.

We encourage APG members to take advantage of our Advocacy events to learn more about how to support our requests for record access, increased digitization, and increased funding. You can still get involved by writing to your Congress and House representatives and ask them to sign on to these letters when they are published in the next two weeks.

Conestoga-Susquehannock Tribal Historian Michael Mantooth will take us deeper into the hidden history found in genealogical documents. He'll offer insights into researching Indigenous ancestry in states without currently recognized tribes, and how shifting classifications—where indigenous people were often recorded as black, white, or colored—complicate the search.

Michael will share examples that challenge the widely accepted story of his people's extinction, backed by over 175 years of efforts to reclaim their treaty land. He'll also highlight some lesser-known resources that can reveal genealogical clues traditional methods often miss.



Our next meeting is on 21 May 2025 at 2:00 p.m. ET when Ian Watson will speak on "Genealogical Writing and Publishing in the 2020s: Thoughts from Ian Watson, Editor of the NYG&B Record."

Ian Watson will share his thoughts about how the environment for genealogical writers and publishers is changing. Kevin Smith will give an overview of how the Cold Case Team/ FIGG team of Indiana State Police (ISP) developed in-house, and how it uses genealogy as another tool to help solve cases.
